| Arrest | The person (or persons) involved was arrested or an arrest warrant was obtained. |
| Referred | The case was referred to, or managed by, another law enforcement agency or administrative body such as the Durham police Department, Office of Institutional Equity, Student Conduct, etc. |
| Inactive | The case was reviewed and inactivated due to lack of solvability factor(s). Cases may be reactivated at any time in the event new information becomes available. |
| Exceptionally Cleared | The case was cleared by death of offender; victim refused to cooperate; or prosecution was declined. |
| Pending | The case is under further investigation. |
| Unfounded | The reported crime did not occur. |
