DISPOSITION DEFINITIONS (as of April 18, 2016)

Arrest	The person (or persons) involved was arrested or an arrest warrant was obtained.
Referred	The case was referred to, or managed by, another law enforcement agency or administrative body such as the Durham police Department, Office of Institutional Equity, Student Conduct, etc.
Inactive	The case was reviewed and inactivated due to lack of solvability factor(s). Cases may be reactivated at any time in the event new information becomes available.
Exceptionally Cleared	The case was cleared by death of offender; victim refused to cooperate; or prosecution was declined.
Pending	The case is under further investigation.
Unfounded	The reported crime did not occur.
