DISPOSITION DEFINITIONS (as of April 18, 2016)

- Arrest** The person (or persons) involved was arrested or an arrest warrant was obtained.
- Referred** The case was referred to, or managed by, another law enforcement agency or administrative body such as the Durham police Department, Office of Institutional Equity, Student Conduct, etc.
- Inactive** The case was reviewed and inactivated due to lack of solvability factor(s). Cases may be reactivated at any time in the event new information becomes available.
- Exceptionally Cleared** The case was cleared by death of offender; victim refused to cooperate; or prosecution was declined.
- Pending** The case is under further investigation.
- Unfounded** The reported crime did not occur.
