<b>Referred</b>	The case was referred to, or managed by, another law enforcement agency or administrative body such as the Durham police Department, Office of Institutional Equity, Student Conduct, etc.
<b>Inactive</b>	The case was reviewed and inactivated due to lack of solvability factor(s). Cases may be reactivated at any time in the event new information becomes available.
<b>Exceptionally Cleared</b>	The case was cleared by death of offender; victim refused to cooperate; or prosecution was declined.
<b>Pending</b>	The case is under further investigation.
<b>Unfounded</b>	The reported crime did not occur.
